## ORDER

3. That the engagement shall be purely based on performance/conduct & behaviour to be monitored & evaluated by the concerned Chairman of the Centre periodically.


The engagee shall be required to produce the following documents in the Administration-TW:

  - j) She shall pave way as and when the post is filled either by regular appointment or by transfer as the case may be, if he/she is engaged against duly sanctioned post.;


